The portfolio will invest in 20 to 30 companies located outside the United States, diversified by industry and country.

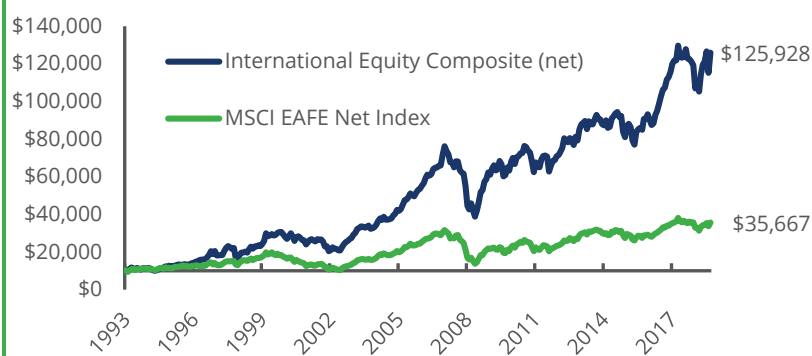

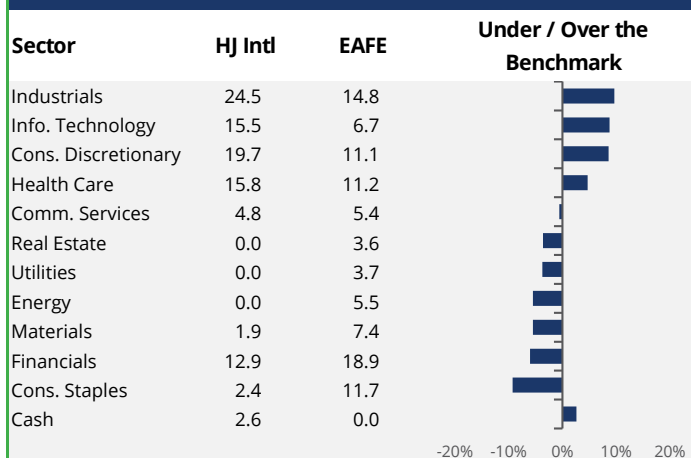

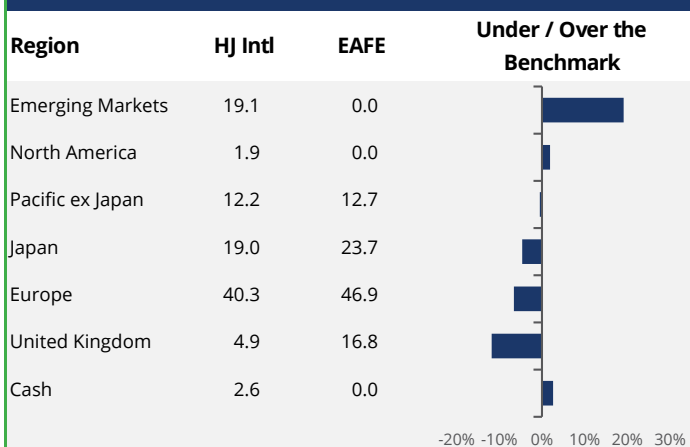
